**CALL TO ORDER :**

Councilmember Alessio called the meeting to order at 2:04 p.m.

**PRESENT:** Councilmembers Alessio and Weber

**APPROVAL OF MINUTES:**

**CURRENT BUSINESS**

**1. UPDATES ON SHORT TERM PROJECTS**

- a. Community garden: The City has entered into an operating agreement with the La Mesa Park and Recreation Foundation for the use of approximately .75 acres that was the former putting green and golf club house for the purpose of a community garden. The grass has been removed, a committee is preparing forms and seeking funding/grants for the estimated \$45,000 cost to build. Received a \$5,000 grant from the San Diego Chapter of the American Society of Landscape Architects.
- b. Picnic area at the entrance to the park is complete.
- c. Events have been cancelled due to COVID. The park is getting a lot of use.
- d. Community Center Renovation is completed with a few remaining punch list items, however, closed due to COVID for events.

**2. MAC ARTHUR PARK MASTER PLAN**

Director Richardson reviewed a presentation with the two proposed concept plans created by the consultant based on public input which will be shared with the community as an online presentation and survey, due to not being able to host an in person workshop. Committee members provided input on the presentation. The survey will be open until July 20, 2020.
