Some provisions of the La Mesa Municipal Code Chapter 8 are summarized below for the guidance of the dog owner.

All dogs over four months of age are required to be licensed. No license shall be issued unless the dog has been immunized against rabies with a vaccination that will remain valid for the licensing period. Vaccination must be administered by any duly qualified and licensed veterinarian, with a rabies vaccine approved by the State Department of Health for use in dogs.

The license tag shall be firmly attached to the dog's collar and worn at all times except when the dog is confined with the owner's dwelling or when being exhibited at a dog show.

In all areas of the City the dog must be leashed securely when off the owner's premises.

Failure to procure a license within 30 days from the date on which the dog is required to be licensed will result in the appropriate penalty fee.
